## GENERAL FOOD VENDOR INFORMATION:

Each food vendor space is limited to an area of approximately 20' by 20', unless prior arrangements have been made. Vendor placement is at the sole discretion of the Johnny Appleseed Association staff. Vendors are responsible for maintaining their area, clean up, and trash removal. Vendors will only be allowed to bring vehicles into the vendor area one hour prior to the start of the festival and after the close of the festival for unloading or loading. **NO SALES OF COTTON CANDY OR APPLE DUMPLINGS ARE ALLOWED DUE TO PRE-EXISTING CONTRACTS .**

## CRAFT VENDORS/ANTIQUES VENDORS & COMMERCIAL DISPLAYS

Each vendor space will be 10' by 10' with a 2 foot aisle between booths. No displays shall project more than 12 inches in front of your booth. No tents, tables, or chairs will be provided. Please be considerate of the vendor to either side of you.

**No firearms, fireworks, alcoholic beverages, or articles of a sexual nature are permitted.**

## INSURANCE:

All ride and food vendors need to show "Certificate of Liability Insurance" with the Lisbon Area Chamber of Commerce/ Johnny Appleseed Festival listed. **Certificates must be sent with your application.**

## TAXES:

All taxes are the responsibility of the vendor.

## HOW TO APPLY:
